NOTIFICATION OUT

SSC MTS (Multi Tasking Staff) is a non-technical exam which is organized by Staff Selection Commission. SSC has released the notification of SSC MTS 2021. The last date to apply for the MTS 2021 is 21st July 2021. The online examination is to be held from 1st July 2021 onwards. In order to apply for the examination, SSC aspirants can visit <https://ssc.nic.in/>.

This article will elaborate each and every detail about SSC MTS examination, notification, eligibility and more. It is non-technical exam held at national level for the recruitment of non-gazette and non-ministerial posts in various government departments.

Posts of SSC MTS 2021 examination

Recruitment on various posts is done through SSC MTS 2021. They are:

Vacancies details

The details of number of vacancies are not provided yet. Generally, SSC notifies about the number of vacancies prior to declaration of final results. For now, here is the detail of vacancies in SSC MTS-2019. 7099 vacancies were declared in 2019-2020 examination.

Eligibility criteria

Before applying online for the SSC MTS 2021 exam, candidates must ensure that they fulfil all the eligibility criteria to avoid any issue later. Go through the eligibility criteria as provided by the Staff Selection Commission thoroughly before you move ahead with the online application. Failing to meet the eligibility criteria at any level, you will not be permitted to fill the form. In case, any misinformation is found at later stages of the exam, one can be disqualified or barred from the future examinations as well.

Nationality

As per Nationality, SSC MTS Recruitment specifies that an applicant to be a citizen of the listed states only. A candidate must comply with all of the mentioned criteria:

- (a) a citizen of India, or
- (b) a subject of Nepal, or
- (c) a subject of Bhutan, or
- (d) a Tibetan refugee who came over to India, before the 1st January 1962, with the intention of permanently settling in India, or
- (e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (Formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia, and Vietnam with the intention of permanently settling in India.

Age Limit

The age limit for different positions according to the SSC MTS Recruitment rules is:

18-25 years as on cut-off date (i.e., candidates born not before 02-01-1996 and not later than 01-01-2003).

18-27 years as on cut-off date (i.e., candidates born not before 02-01-1994 and not later than 01-01-2003).

Note: The Age calculation: As on 01.01.2021
