- The 41 hymns of Guru Ravidas have been included in the Guru Granth Sahib.
- The famous saint poetess, Mirabai was a disciple of Guru Ravidas.
- According to his teachings: everybody is equal in all respects, irrespective of caste, color or a belief in any form of God; Emphasised on universal brotherhood and tolerance. God created man and not man created God.

#### GOV OF KERALA TO BUILD 'SMART' ANGANWADIS


The Energy and Research Institute (TERI) has signed an MoU with the Power System Corporation of India (POSOCO).

- The VL-SRSAM is developed by DRDO and was launched for the Indian Navy.
- It has a strike range of 40-50 km and provides defence against aerial and water targets.

#### **Key Points:**

- The MoHUA mentioned that the 'National Urban Digital Mission' will lead to having an institutionalised citizen-centric and ecosystem-driven approach for transparent urban governance and service delivery in cities by 2022, and in all Indian cities and towns by 2024.
- Due to this mission, the Indian cities and towns will get the benefit of holistic and diverse forms of support of various digital initiatives of the MoHUA.
- During the event of launching of the mission, various other initiatives were also launched: India Urban Data Exchange (IUDX), SmartCode, Smart Cities 2.0 website, and Geospatial Management Information System (GMIS).

# ARTISAN-BASED SFURTI CLUSTERS INAUGURATED



Date: 25th February 2021

Fifty artisan-based Scheme of Fund for Regeneration of Traditional Industries (SFURTI) clusters, spread over 18 States, was recently inaugurated by the Ministry of MSME.

#### **Key Points:**

- Artisans shall be supported in the traditional segments of muslin, khadi, coir, handlooms, woodcraft, pottery, carpet weaving, agro-processing, etc.
- Objective of the SFURTI is to organize traditional industries and artisans into clusters to make them competitive and increase their income.
- SFURTI clusters are of two types:
- Regular Cluster (500 artisans) with Government assistance of up to Rs.2.5 crore
- Major Cluster (more than 500 artisans) with Government assistance up to Rs.5 crore.

#### PRODUCTION LINKED INCENTIVE SCHEME FOR PHARMACEUTICALS



Date: 25th February 2021

The Union Cabinet has approved Production Linked Incentive (PLI) Scheme for Pharmaceuticals for Financial Year 2020-21 to 2028-29.

# **Key Points:**

- The Scheme is expected to bring in investment of Rs.15,000 crore in the pharmaceutical sector.
- It will be part of the umbrella scheme for the Development of the Pharmaceutical Industry.
- Objective: (1) To enhance India's manufacturing capabilities by increasing investment; (2) Product diversification to include high-value goods.
- Target Groups: The manufacturers who are registered in India will be grouped based on their Global Manufacturing Revenue (GMR) to ensure wider applicability of the scheme

#### **INFORMATION TECHNOLOGY**

**LAUNCH OF INDIA URBAN DATA EXCHANGE (IUDX)** 



Date: 26th February 2021

India Urban Data Exchange (IUDX) was launched recently by the Ministry of Housing and Urban Affairs.

#### **Key Points:**

- IUDX has been developed in partnership between the Smart Cities Mission and the Indian Institute of Science (IISc), Bengaluru.
- IUDX serves as an interface for data providers and data users.
- Its objective is to share, request, and access datasets related to cities, urban governance, and urban service delivery.
- It is an open-source software platform.
- It will ensure secure and authenticated exchange of data amongst various data platforms.

# PRIVATE SECTOR BANKS TO CONDUCT GOVERNMENT-RELATED BANKING TRANSACTIONS



Date: 26th February 2021

The Government has lifted the embargo on private sector banks for the conduct of Government-related banking transactions.

#### **Key Points:**

- These will include taxes and other revenue payment facilities, pension payments, small savings schemes, etc.
- Only a few banks were permitted to carry out these functions earlier.
- Besides, there is now no bar on RBI for authorization of private sector banks for Government business.
- For undertaking government agency business, the RBI pays a commission to banks.
- The Reserve Bank of India (RBI) carries out the general banking business through agency banks appointed under Section 45 of the RBI Act, 1934.

#### PRODUCTION LINKED INCENTIVE SCHEME FOR IT HARDWARE



Date: 26th February 2021

The Union Cabinet has approved the Production Linked Incentive (PLI) Scheme for IT Hardware.

# **Key Points:**

- The scheme proposes PLI to boost domestic manufacturing and attract large investments in the value chain of IT Hardware.
- The Scheme shall extend an incentive of 4% to 2% on net incremental sales (over base year 2019-20) of goods manufactured in India and covered under the target segment, for 4 years.
- It will benefit 5 major global players and 10 domestic champions in the field of IT Hardware manufacturing including Laptops, Tablets, All-in-One PCs, and Servers.

**INDIAN ECONOMY TO CONTRACT BY 8% IN 2020-21 – BY NSO** 



Date: 26th February 2021

The National Statistical Office (NSO) has estimated that India's GDP to contract by 8% in FY 2020-21.

#### **Key Points:**

- Initially, it has projected GDP contraction to 7.7% for FY 2020-21.
- Also in the December quarter, the Indian economy will be expanded by 0.4%.
- With this, the economy will emerge from the recession which occurred due to the pandemic.

#### SIDBI SIGNED MOU WITH ANDHRA PRADESH GOV.



Date: 28th February 2021

The Small Industries Development Bank of India (SIDBI) has signed an MoU with the Government of Andhra Pradesh for the development of the MSME ecosystem in the state.

- Under this MoU, a Project Management Unit (PMU) will be set up by SIDBI.
- The PMU will help to frame schemes and programmes to uplift the MSME ecosystem in the state.
- The schemes and programmes will be in areas like equity support, interest subvention, resolution of stressed MSMEs, supporting MSME entrepreneurs and facilitate other need-based intervention.
- The PMU will also analyse the current status of various schemes and programmes which are framed to uplift MSMEs and will accordingly make modifications if required.

India and Maldives signed Various Agreements

India and Maldives have signed multiple agreements in various areas to boost the bilateral cooperation between them.

## **Key Points:**

- Total 5 agreements are signed between both nations which will help to boost infrastructure in the island nation.
- Following are the details of each agreement.
- The EXIM Bank of India and Fahi Dhiriulhun Corporation signed a Letter of Intent (LoI) for financing 2,000 social housing units in Hulhumale.
- MoU to establish Geydhoshu Masplant in Noonu Kendhikulhudhoo. This will help to develop small-scale fish processing plants in the Maldives.
- The EXIM Bank of India and the government of Maldives signed the Second Amendatory Dollar Credit Line Agreement. This agreement will help to develop roads in the island nation.
- MoU was signed to have capacity building and exchange of data between Prasar Bharati and Public State Media, Maldives.
- The Ministry of Housing and Urban Affairs of GOI and the Ministry of National Planning, Housing and Infrastructure of Maldives signed an agreement for sustainable urban development.

GOI AND WORLD BANK TO IMPROVE SCHOOL EDUCATION IN NAGALAND

The Indian Government, the Government of Nagaland and the World Bank have signed an agreement to enhance school education in Nagaland.

#### **Key Points:**

- They have signed a loan agreement of USD 68 million for the same.
- The agreement is signed for the project called 'Nagaland: Enhancing Classroom Teaching and Resources Project'.
- This project aims to improve teaching methods and the learning environment in the state.
- The project will prove beneficial to 1,50,000 students and 20,000 teachers.
- The project will undertake activities like: Improving classroom instructions, developing opportunities to have professional development of teaching staff, developing advanced technology based learning systems for online as well as offline mode of teaching, framing policies and programs.


Why in news: Honored with the new International Anti-corruption Champions Award.

Why in news: Became a United Nations goodwill ambassador.

- Russian supermodel and philanthropist Natalia Vodianova became a United Nations goodwill ambassador
- She will promote the sexual and reproductive rights of women and girls and tackle stigmas surrounding their bodies.
- She will be a campaigner for the U.N. Population Fund, which now calls itself the UN's sexual and reproductive health agency, known as UNFPA.
- Vodianova founded the Naked Heart Foundation to help children with special needs and their families in 2004 and is a member of the Special Olympics International board of directors.
- She made the Forbes top models list in 2012 and is nicknamed Supernova.

#### HEALTHCARE

#### NON-ALCOHOLIC FATTY LIVER DISEASE (NAFLD)



Date: 23rd February 2021

### **Key Highlights:**

- According to the Health Ministry, India has become the first country in the world to identify the need for action for Non-Alcoholic Fatty Liver Disease.
- Operational guidelines have been launched for the integration of NAFLD with the National Programme for Prevention & Control of Cancer, Diabetes, Cardiovascular Diseases, and Stroke.
- NAFLD is an umbrella term for a range of liver conditions affecting people who drink little to no alcohol.
- Main characteristic of NAFLD is too much fat stored in liver cells.
- It is becoming increasingly common around the world, especially in Western nations.
- Some individuals with NAFLD can develop non-alcoholic steatohepatitis (NASH).
- NASH is an aggressive form of fatty liver disease, marked by liver inflammation which may progress to advanced scarring (cirrhosis) and liver failure.

**AMENDMENTS MADE TO THE RIGHT TO INFORMATION ACT**

#### **Key Highlights:**

- The Supreme Court has criticised the Union government for having not filed a reply to a petition by parliamentarian Jairam Ramesh challenging the amendments made to the Right to Information Act for over a year.
- The petitioner argues that the amendments gave the Centre unparalleled powers to dictate the tenure, salaries and service conditions of the Chief Information Commissioner and Information Commissioners as per its "whims and fancies".
- The petitioner contended that the RTI Amendment Act of 2019 and its Rules cripple the objectivity and independence of the Central Information Commission (CIC) by bringing under the yoke of the government.
- The amendments made in the RTI Act last year are seen as a "threat to the independence" of the Central Information Commissioner.

# U.P. ASSEMBLY PASSES THE CONTROVERSIAL BILL ON CONVERSION AMID PROTESTS



Date: 26th February 2021

#### **Key Highlights:**

- Uttar Pradesh Legislative Assembly passed Uttar Pradesh Prohibition of Unlawful Conversion of Religion Bill, 2021.
- The Bill seeks to replace the ordinance promulgated in November last year that seeks to curb religious conversions carried out by fraudulent or any other undue means.
- It makes religious conversion for marriage a non-bailable offence.

- The onus will be on the defendant to prove that conversion was not for marriage.
- The ordinance, passed in November 2020, comes days after the Allahabad high court said in a verdict (Salamat Ansari-Priyanka Kharwar case) that the right to choose a partner or live with a person of choice was part of a citizen's fundamental right to life and liberty.
- The law has come under sharp criticism from several legal scholars who had contended that the concept of 'love jihad' did not have any constitutional or legal basis.

# UBER DRIVERS TO BE CONSIDERED WORKERS AND NOT FREELANCE CONTRACTORS: UK SUPREME COURT



Date: 24th February 2021

# **Key Highlights:**

- The UK Supreme Court ruled that Uber drivers were to be considered workers and not freelance contractors.
- This order shall make them eligible for all employment related benefits such as minimum wage, annual leaves, and insurance.
- With this ruling, Uber and other service providing platforms could also potentially face legal and regulatory challenges in India.
- Besides, Indian budget 2021-22 has mandated that the law on minimum wages would now apply to workers of all categories including those associated with platforms such as Uber.
- Such workers would now be covered by the Employees State Insurance Corporation (ESIC).
- In November 2020, the government had come out with specific norms for apps such as Uber and Ola.

# **CHINA-PAKISTAN ECONOMIC CORRIDOR (CPEC)**

# **Key Highlights:**

- Pakistan Prime Minister Imran Khan has said that he was looking forward to enhancing trade ties with Sri Lanka through the multi-billion dollar China-Pakistan Economic Corridor (CPEC).
- The CPEC is the flagship project of the multi-billion-dollar Belt and Road Initiative (BRI), a pet project of China, aimed at enhancing Beijing's influence around the world through China-funded infrastructure projects.
- CPEC aims at linking the city of Gwadar in Pakistan to China's Xinjiang region through a vast network of highways and railways.
- India's concern is that it passes through PoK.
- CPEC rests on a Chinese plan to secure and shorten its supply lines through Gwadar with an enhanced presence in the Indian Ocean.
- Hence, it is widely believed that upon CPEC's fruition, an extensive Chinese presence will undermine India's influence in the Indian Ocean.

#### **Key Features:**

- SmartCode Platform was recently launched by the Ministry of Housing and Urban Affairs.
- SmartCode is a platform that enables all ecosystem stakeholders to contribute to a repository of open-source code for various solutions and applications for urban governance.
- It is designed to address the challenges that urban local bodies (ULBs) face in the development and deployment of digital applications.
- It shall enable cities to take advantage of existing codes and customise them to suit local needs, rather than having to develop new solutions from scratch.
- The source code will be free to use without any licensing or subscription fees.

#### CARBON WATCH APP

#### **Key Features:**

- Chandigarh became the first state or Union Territory in India to launch Carbon Watch, a mobile application to assess the carbon footprint of an individual.
- A carbon footprint is the total amount of greenhouse gases—primarily carbon dioxide—released into the atmosphere by a particular human activity.
- The app focuses on individuals' actions and calculates carbon footprint on the basis of Transport, Energy, Waste and Water consumption.
- It will also provide information such as the national and world average of the emission, and the individual's level of emission generation.
- It encourages people to be Climate-Smart Citizens while making them capable of accessing their carbon footprint, along with providing them with steps to reduce it.
- It also sensitizes people about their lifestyle emissions, their impact and possible countermeasures to mitigate the same.

# **Key Features:**


- The optical telescope set up at Devasthal has assumed global importance for observing important cosmic explosive events such as Gamma-Ray Bursts and Supernovae.
- Devasthal is a mountain peak in Uttarakhand.
- It is a world-class 3.6 m optical telescope.
- It is Asia's largest fully steerable optical telescope.
- It was set up by the Aryabhatta Research Institute of Observational Sciences (ARIES), an autonomous research institute of DST, with support from the Belgian government in 2016.

• It will also be helpful for future optical facilities such as the Thirty Meter Telescope.

#### **NEW LEAD (PB) FREE MATERIAL DISCOVERED**

# **Key Features:**

- Scientists at Jawaharlal Nehru Centre for Advanced Scientific Research (JNCASR), Bengaluru have found a new Lead (Pb) free material.
- It is called Cadmium (Cd) doped Silver Antimony Telluride (AgSbTe2).
- It can efficiently convert waste heat to power our small home equipment and automobiles.
- Most efficient thermoelectric materials developed so far use Lead (Pb) as a major constituent element, restricting their use for mass-market applications.
- This work is supported by Swarna-Jayanti fellowship. The Swarna Jayanti Fellowships scheme provides special assistance and support to a selected number of young scientists with a proven track record to enable them to pursue basic research in frontier areas of science and technology.

#### **BAD BANK**

#### **Key Features:**

• The Indian Banks' Association (IBA) has begun identifying bad loans which can be transferred to the Centre's proposed bad bank.

- The IBA has written to banks asking them for a list of all bad loans worth Rs 500 crore and above to "identify magnitude of the problem" and "get clarity over initial capital required for the entity".
- Finance Minister Nirmala Sitharaman had proposed setting up of a bad bank during her Union Budget 2021 speech on February 1.
- A bad bank is a bank set up to buy the bad loans and other illiquid holdings of another financial institution.
- The entity holding significant nonperforming assets will sell these holdings to the bad bank at market price.
- By transferring such assets to the bad bank, the original institution may clear its balance sheet—although it will still be forced to take write-downs.
