

## Exam Pattern & Syllabus

#### **RBI Grade B Exam**

Every year Reserve Bank of India (RBI) conducts the RBI Grade B Officer Exam to select eligible candidates for the position of Grade B officer in its various branches all across the country. As the Reserve Bank of India offers an excellent pay scale and a reputed job profile, it lures thousands of candidates every year to take this examination.

#### **Nationality**

The candidate must be a citizen of India or a subject of Nepal or Bhutan, or a Tibetan refugee who is permanently settled in India before January 1, 1962, or a person of Indian origin who has migrated from either Pakistan, Burma, Sri Lanka, Kenya, Uganda, Tanzania, Zambia, Malawi, Zaire, Ethiopia, or Vietnam intending to reside permanently in India.

RBI Grade B Age Limit Minimum age limit: 21 years Maximum age limit: 30 years

- (a) Officers in Grade 'B' (DR)–(General): Minimum 60% marks (50% in case of SC/ST/PwBD) or an equivalent grade in Bachelor's degree as well as in 12th (or Diploma or equivalent) and 10th Standard examinations. The minimum qualifying percentage or an equivalent grade for the Bachelor's degree will be in aggregate for all semesters/years.

  - (c) Officers in Grade 'B' (DR)–DSIM: Master's Degree in Statistics/ Mathematical Statistics/ Mathematical Economics/ Econometrics/ Statistics & Informatics from IIT-Kharagpur/ Applied Statistics & Informatics from IIT-Bombay with a minimum of 55% marks or equivalent grade (aggregate of all semesters/years) OR Master's Degree in Mathematics with a minimum of 55% marks or an equivalent grade in aggregate of all semesters/years and a one-year postgraduate diploma in Statistics or related subjects from a reputed Institute OR M. Stat. Degree of Indian Statistical Institute with a minimum of 55% marks (aggregate of all semesters/years) OR Post Graduate Diploma in Business Analytics (PGDBA) jointly offered by ISI Kolkata, IIT Kharagpur, and IIM Calcutta with a minimum of 55% marks or equivalent grade in aggregate of all semesters/years.

#### **RBI Grade B Exam Number of attempts**

General Candidates: 6 Attempts

SC/ST/OBC/PWD Candidates: No bar on number of attempts.

#### **RBI Grade B Exam Pattern**

RBI Grade B 2023 Exam will be conducted in three phases:

Phase-I or Prelims;

Phase-II or Mains

Interview

Candidates are required to clear all three phases to get a confirmed post as a Grade B Officer in the Reserve Bank of India. The Final merit list will be based on candidates' performance in the main exam and interview round.

#### **RBI Grade B Exam Pattern For Prelims Exam**

The RBI Grade B Prelims exam will be of 200 marks with a total time duration of 120 minutes.

There will be a specific sectional duration which will be mentioned in the admission letter.

There will mainly be four sections.

#### **RBI Grade B Exam Pattern For Mains Exam**

The candidates who qualify for the Prelims will be eligible to appear for the mains exam or Phase 2.

There are three separate papers in the main exam.

For RBI Grade B Officers in Gr B (DR)- General, candidates have to appear for Paper I, II, and III.

For RBI Grade B Officers in Gr B (DR)- DEPR & DSIM, candidates have to appear for Paper-II, and III.

Paper I & III are 50% Objective & 50 % descriptive while Paper- II is Descriptive only.

Each paper will be of 100 marks.

The English paper is a descriptive test.

#### **RBI Grade B Officer Interview**

Candidates will be shortlisted for the interview, based on aggregate marks obtained in Paper-II, Paper-II, and Paper-III of the Phase II exam. The interview process will carry 75 marks.

#### **RBI Grade B Syllabus**

As you know that there will be three phases for the selection of RBI Grade B Officers. The first two being the written tests and the third being the Interview.

The RBI Grade B phase-1 exam is an objective type examination conducted online. It will have 4 sections: General Awareness, English Language, Quantitative Aptitude, and Reasoning

The RBI Grade B Phase II Exam is both objective & descriptive type. This phase will focus upon Economic & Social Issues, English Language and Finance & Management.

#### **Current Affairs Refresher**

#### **Economy & Banking**

#### **Union Budget 2023-24**

The Finance Minister of India called it the first Budget in Amrit Kaal. The vision for the Amrit Kaal is an empowered and inclusive economy that is technology-driven and knowledge-based with a robust financial sector.

#### **Key Highlights:**

- A key theme of Union Budget 2023-24 is the focus on inclusive development Sabka Sath, Sabka Vikas which specifically covers Farmers, Women, Youth, Scheduled Castes, Scheduled Tribes, Other Backward Classes (OBCs), Divyangjan (PwDs) and Economically Weaker Sections (EWS).
- Key Takeaways of the Budget Changes in the new income tax regime (in rebate limit and in tax slabs).
- A 33% increase in capital investment outlay has been proposed, raising it to Rs 10 lakh crore (the biggest in the past decade).
- Changes in customs duty; reduced on import of certain inputs for mobile phone manufacturing, shrimp feed etc. and increased on cigarettes, gold articles, compounded rubber etc.
- Capital outlay for the railways increased to the highest ever Rs 2.40 lakh crore.
- 157 new nursing colleges will be established in co-location with the existing 157 medical colleges established since 2014.
- A Mission to eliminate Sickle Cell Anaemia by 2047 will be launched.

#### Delhi Budget 2023-24

Delhi Budget for the present financial year 2023-24 was presented by the Delhi Finance Minister Shri Kailash Gahlot. This budget session was held in the Delhi Assembly on March 22, 2023

#### **Key Points:**

- Out of the total budget of Rs 78,800 crores, 22,000 crores has been selected for expenditure on infrastructure while Rs 550 crores are kept for advertisements.
- The allocation for advertisements remains the same.
- Focus on Clean & Modern Delhi The government has proposed to instigate infrastructure facilities across the busiest city of Delhi.
- The aim is to enhance the city which will start by cleaning Yamuna and other waste materials will be removed, as per the budgetary allocation.
- It talks about Education, Health, Greener city, Deshbhakti, Zero Tax, and Rozgar Budgets in the session that was held.
- A senior official claimed that the theme of the 2023-24 budget is "Saaf, Sundar aur Adhunik Dilli" (clean, neat and modern Delhi).
- About 84 per cent of Delhi's population benefitted from power subsidies.
- By 2025, a 6,000-megawatt solar infrastructure is intended to be established.

#### MPC's First Bi-Monthly Monetary Policy of FY2023-24

The Reserve Bank of India's (RBI's) Monetary Policy Committee (MPC) recently announced the first bi-monthly monetary policy of FY2023-24.

#### **Key Points:**

- RBI Governor Shaktikanta Das revealed that the MPC has unanimously decided to keep the repo rate unchanged at 6.50%.
- This key lending rate is the rate at which the RBI lends money to commercial banks.
- The decision to pause the repo rate is only for this meeting, but the committee will not hesitate to take further action as may
  be required in its future meetings.

#### **India and Malaysia Agree to Settle Trade in Indian Rupees**

India and Malaysia have agreed to settle trade in Indian rupees. This mechanism is expected to enhance India-Malaysia bilateral trade which touched USD 19.4 billion during 2021-22.

#### **Key Points:**

- Malaysia is the third largest trading partner of India in the ASEAN region, after Singapore and Indonesia that account for USD 30.1 billion and USD 26.1 billion bilateral trades with India respectively.
- In July 2022, the Reserve Bank of India (RBI) allowed the settlement of international trade in Indian rupees.
- In March 2023, banks from 18 countries were allowed by the RBI to open Special Rupee Vostro Accounts (SRVAs) to settle payments in Indian rupees.

#### Core sector growth slows to 5-month low in March

Growth in core infrastructure industries moderated to a five-month low in March at 3.6% year-on-year, partly due to the base effect but also because of unseasonal rains.

#### **Key Points:**

- Only two sectors coal and crude petroleum registered sequential improvement.
- The data comes at a time when there is expectation of a slowdown in economic activities, but is at odds with other high frequency indicators such as the PMI and revenue from the Goods and Services Tax registering robust expansion in the month.
- This is the slowest growth in core sector industries since October 2022 when it registered a mere 0.7% expansion.
- March's core sector growth was also the second-lowest in FY23.
- The eight core industries grew by 4.8% in March, 2022 and by 7.2% in February, 2023.

#### **Mission Har Payment Digital**

The Reserve Bank of India (RBI) has launched a new mission called "Har Payment Digital" as part of its efforts to make every Indian a user of digital payments during "Digital Payments Awareness Week".

#### **Key Points:**

- The initiative was launched during Digital Payments Awareness Weekbetween (March 6, 2023, and March 12, 2023) and aims to reinforce the ease and convenience of digital payments, while also onboarding new users.
- The central bank has started an initiative to adopt 75 villages and transform them into digital payment-enabled villages. These villages are to be adopted by payment system operators.
- Banks and payment system operators will promote the Har Payment Digital campaign and highlight the various payment channels available.
- The RBI's Regional Offices will also promote the acceptance and use of digital payments through the Jan Bhagidari activities as part of this initiative.

#### SBI reintroduces 'Amrit Kalash' scheme

SBI has announced the re-introduction of its retail term deposit scheme, Amrit Kalash.

#### **Key Points:**

- The scheme offers a special tenor of 400 days and provides an interest rate of 7.6% for senior citizens and 7.1% for others.
- This deposit scheme had previously been launched by SBI on February 15, 2023, and was valid till March 31, 2023.
- The reintroduction of this scheme provides customers with another opportunity to avail themselves of the attractive interest rates offered by SBI.

#### **First Republic Bank Collapse**

The bank's stock has plummeted about 75% in the last week of April, after a disappointing first-quarter earnings report revived Wall Street's fears about a banking crisis and catalyzed an exodus out of First Republic stock.

#### **Key Points:**

- Trouble for First Republic started brewing after the company reported that its total deposits fell 41% in the first quarter to \$104.5 billion.
- Analysts had expected deposits of around \$136.7 billion.
- About two-thirds of First Republic's deposits were uninsured with the FDIC when the banking turmoil took hold in March, lower than the 94% at Silicon Valley Bank.

#### **Economic Survey 2023**

The Survey laid out the outlook for India's growth, inflation and unemployment in the coming years.

#### **Key Points:**

• India is to witness GDP growth of 6.0 per cent to 6.8 per cent in 2023-24, depending on the trajectory of economic and political developments globally.

- Economic survey 2022-23 projects a baseline GDP growth of 6.5 per cent in real terms in the Financial Year 2023-2024.
- Indian Economy is expected to grow at 7 per cent (in real terms) for the year ending march 2023. This follows an 8.7 per cent growth in the previous financial year. So, the Indian growth rate is decreasing. However, a similar or much worse trend is there across the globe.
- Credit growth to the micro, small, and medium enterprises (MSME) sector has been remarkably high, over 30.5 per cent, on average during Jan-Nov 2022.

• Fiscal Deficit: 6.4% of GDP

#### **CU-Chayan Portal**

#### **Key Points:**

- The portal, CU-Chayan, will provide a consolidated list of job openings across all 46 central universities under the Union Ministry of Education.
- According to the Union Government's recent submission in the Lok Sabha, nearly 31% of sanctioned positions in central universities are vacant.
- This portal will address this issue by fast tracking the recruitment process.

#### **Government Policies & Schemes, Agreements & Deals**

#### **Draft 'Sagarmala Innovation and Start-up Policy'**

The Ministry of Ports, Shipping and Waterways has recently issued the Sagarmala Innovation and Start-up Policy to encourage innovation and entrepreneurship in the maritime sector in India.

#### **Key Points:**

- The policy aims to create a conducive environment for the growth of start-ups and other entities in the maritime sector, leading
  to sustainable development and employment opportunities.
- The primary objective of the Sagarmala Innovation and Start-up Policy is to nurture start-ups and other entities to co-create the future of India's growing maritime sector.
- The policy aims to create an innovation ecosystem that promotes entrepreneurship, innovation and technology in the maritime sector

#### **Support for Poor Prisoners Scheme**

The Indian government has recently launched a special scheme called 'Support for Poor Prisoners,' aimed at providing financial assistance to poor prisoners who are unable to pay the penalty or the bail amount.

#### **Key Points:**

- The scheme was announced by the Home Ministry on April 7th, 2023, to provide financial support to poor people languishing in jails.
- The primary objective of the scheme is to provide financial support to poor people who are in prisons and are unable to afford the penalty or the bail amount.
- The Centre will provide financial support to states to ensure that benefits reach the poor prisoners.
- Legal Services Authority provides free legal aid to poor prisoners at various levels, ensuring that they are not left alone to face the legal system.

#### Promotion of Tribal Products from North-Eastern Region (PTP-NER) Scheme

Arjun Munda, the Minister of Tribal Affairs, has recently launched the Marketing and Logistics Development for Promotion of Tribal Products from North-Eastern Region (PTP-NER) scheme in Manipur.

#### **Key Points:**

• This ambitious scheme aims to enhance procurement, logistics, and marketing efficiency of tribal products from the North-Eastern Region and strengthen the livelihood opportunities of tribal artisans.

• The PTP-NER scheme will be implemented in 8 states in the North-Eastern Region i.e., Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Tripura, and Sikkim.

#### **CBDT Signs 95 Advance Pricing Agreements**

The Central Board of Direct Taxes (CBDT) has entered into a record 95 Advance Pricing Agreements (APAs) in FY 2022-23 with Indian taxpayers.

#### **Key Points:**

- This includes 63 Unilateral APAs (UAPAs) and 32 Bilateral APAs (BAPAs).
- This is the maximum number of BAPAs that CBDT has signed in any financial year till date.
- Mutual Agreements with India's treaty partners namely Finland, the UK, the US, Denmark, Singapore, and Japan led to the signing of the BAPAs.

#### **Rupee Vostro Account system**

The Rupee Vostro Account system is a financial arrangement that enables foreign banks to conduct transactions in Indian rupees with domestic banks.

#### **Key Points:**

- The Rupee Vostro Account system is a financial arrangement that enables foreign banks to conduct transactions in Indian rupees with domestic banks.
- RBI regulates the Rupee Vostro Account system, which allows foreign banks to maintain accounts with domestic banks to facilitate trade and investment activities in India.
- The system provides a secure and transparent mechanism for foreign banks to conduct transactions in Indian rupees without having to set up a local branch in India.
- Foreign banks that wish to establish a Rupee Vostro Account must first obtain approval from the RBI. Once approved, the foreign bank can open an account with a domestic bank and deposit funds in Indian rupees.

#### **ALMA Telescope**

ALMA telescope is to get a new brain. The ALMA is set to get a hardware and software upgrade for the collection of more data and produce sharper images.

#### **Key Points:**

- The Atacama Large Millimetre/submillimetre Array is a cutting-edge radio telescope featuring 66 high-precision antennas.
- This telescope is situated in the Atacama Desert in northern Chile.
- The telescope provided detailed images of protoplanetary discs around HL Tauri. It is a star in the Taurus constellation.

#### New security mechanism for Aadhaar-based fingerprint authentication

The Unique Identification Authority of India (UIDAI) has recently launched a new security mechanism for Aadhaar-based fingerprint authentication.

#### **Key Points:**

- The UDAI is a statutory body that was established by the Indian Government in January 2009.
- It comes under the aegis of the Ministry of Electronics and Information Technology.
- It functions based on the provisions of the Aadhaar (Targeted Delivery of Financial and other Subsidies, benefits and services) Act, 2016.

#### **VLT Survey Telescope**

The VLT Survey Telescope has recently captured a detailed image of IC 4701, an emission nebula found in the Sagittarius constellation.

#### **Key Points:**

- The VLT Survey Telescope (VST) is located at the Paranal Observatory in the Atacama Desert of northern Chile and is adjacent to the four Very Large Telescope (VLT) Unit Telescopes.
- It is located atop the Cerro Paranalmountain.
- The VST is unique as it is the world's largest telescope specifically designed to survey the sky in visible light.
- The program is collaboration between Italy's OAC and the European Southern Observatory (ESO).

#### 'Sagar Manthan', the Real-time Performance Monitoring Dashboard

The Ministry of Ports, Shipping and Waterways has demonstrated its commitment to promoting the growth of India's maritime transport sector by launching the 'Sagar Manthan' Dashboard, which represents a step towards digitalization and transparency in the sector.

#### **Key Highlights:**

- The app has been developed jointly by the Department of Telecommunications and the Bhaskaracharya Institute for Space Applications and Geoinformatics, which operates under the Gujarat government. Its primary aim is to protect the country's underground public infrastructure.

#### **Heat index warning system**

The India Meteorological Department (IMD) is planning to introduce a 'heat index' warning system in Delhi and other parts of the country.

#### **Key Highlights:**

- The IMD has conducted a study on the impact of meteorological factors on heatwaves and the "heat wave hazard zonation" of the country.
- According to "Hot Weather Analysis over India," IMD revealed that the mechanism by which heat impacts humans is complex,
  it is a result of the interactions between temperature, radiation, wind, and humidity.
- Heat Index will calculate the temperature along with the humidity levels to provide a more accurate measure of what the temperature actually feels like.
- The IMD is planning to introduce a similar color-coded warning system in India.

#### **Key Points:**

  rival in the market.
- It was informed that on March 22, early access has been initiated which will let the users collaborate with a generative AI system.
- During the announcement of the developed product, it said that it will continue to bring helpful and modern experiences for people, businesses and several communities around the world.

#### **National Quantum Mission**

Recently, the union cabinet chaired by the Prime Minister has approved the National Quantum Mission (NQM) to aid scientific and industrial research and development in quantum technology.

#### **Key Points:**

- National Quantum Mission will be implemented by the Department of Science & Technology (DST) under the Ministry of Science & Technology.
- The mission planned for 2023-2031 aimed to seed, nurture, and scale up scientific and industrial R&D and create a vibrant & innovative ecosystem in Quantum Technology (QT).
- With the launch of this mission, India will be the seventh country to have a dedicated quantum mission after the US, Austria, Finland, France, Canada and China.

#### Nikhat Zareen wins gold medal in 2023 World Boxing Championship

Indian female boxers continue to create history in the ongoing 2023 World Boxing Championship as Nikhat Zareen beats two-time Asian champion Nguyen Thi Tam 5-0 in the 50kg category to claim the gold medal.

#### **Key Points:**

- With this win, Zareen created history by becoming only the second Indian boxer after veteran MC Mary Kom to win the World Championship title more than once.
- Meanwhile, Nitu Ghanghas (48kg) and Saweety Boora (81kg) won gold medals in respective finals.
- Tipped to be the favourite in this bout, the defending champion didn't let her guard down despite suffering a few blows in the first round.
- She, however, remained ahead with her counter and landed punches, winning crucial moments and the round by a unanimous decision.

#### **Asian Wrestling Championships 2023**

Aman Sehrawat, a freestyle wrestler, won India's 1st gold medal, under the men's 57kg freestyle category, at the Asian Wrestling Championships 2023.

#### **Key Highlights:**

- 36th edition of Asian Wrestling Championships was held in Astana, Kazakhstan, from 9 April to 14 April 2.
- India has won 14 medals(one gold, three silvers and 10 bronze) and is ranked 7th in overall medal tally.
- Kazakhstan was topped in medal tally followed by Japan and Iran.

#### Wisden T20I player of 2022

The Indian duo of Suryakumar Yadav and Harmanpreet Kaur has added another feather to their outstanding crown after bagging the Wisden Almanack's leading cricketer in the World awards.

#### **Key Highlights:**

- Suryakumar won the honour of Wisden Almanack's leading T20I cricketer while Harmanpreet Kaur became the first Indian woman to win the Cricketer of the Year award.
- . Suryakumar's two centuries and nine half-centuries, three of which came in the 2022 T20 World Cup, helped India win 28 of their 40 games last year.
- Suryakumar's maiden T20 hundred came in 2022 with a 55-ball 117 at Nottingham.

#### **Under-20 World Cup**

FIFA has selected Argentina to host the under-20 soccer World Cup after revoking the hosting rights from Indonesia.

#### **Key Highlights:**

- The South American Football Confederation Congress received the official bid from the Argentine Football Association to host the under-20 soccer World Cup from May 20 to June 11.
- This decision was made after Indonesia's football association cancelled the draw scheduled to take place in Bali due to the governor's refusal to host Israel's team.
- Argentina, which has won a record six titles, last hosted the under-20 World Cup in 2001.

#### **State of India's Environment Report 2023**

State of India's Environment report 2023 was launched by Centre for Science and Environment (CSE) and DTE (Down to Earth) magazine, covering an extensive gamut of subject assessments, ranging from climate change, agriculture and industry to water, plastics, forests and biodiversity.

#### **Key Highlights:**

The report is the annual publication, focusing on climate change, migration, health and food systems. It also covers biodiversity, forest and wildlife, energy, industry, habitat, pollution, waste, agriculture and rural development.

According to the report, Over 30,000 water bodies have been encroached on in the country and India is generating 150,000 tonnes of Municipal Solid Waste (MSW) every day — more than half of which is either dumped in landfills or remains unattended.

#### **QS Rankings 2023**

The Indian Institute of Technology-Delhi has been ranked among the top 50 engineering institutions in the QS World University Rankings by Subject 2023.

#### **Kev Highlights:**

• Quacquarelli Symonds (QS) has released a statement indicating that Delhi University has the highest number of entries (27) among Indian universities, followed by the Indian Institute of Technology (IIT), Bombay (25), and IIT Kharagpur (23).

#### **India's Tiger Census - 2022**

The country conducts a scientific estimation of its tiger population once every four years, and the latest report was released by Prime Minister Narendra Modi recently.

#### **Key Points:**

- The report revealed that as of 2022, India's tiger population stands at 3,167, which is a significant increase from the 2006 figure of 1,411.
- The report also shows a decrease in tiger population in the Western Ghats landscape due to the overlap between "wildlife and humans" caused by developmental activities.

#### **Global Terrorism Index 2023**

India ranks 13th on The Global Terrorism Index (GTI). The report shows that Afghanistan continues to be the country most affected by terrorism for the 4th year in a row, even though attacks and deaths decreased.

#### **Key Points:**

- The GTI report is produced by the Institute for Economics & Peace (IEP), a think tank, using data from TerrorismTracker and other sources.
- The dataset contains almost 66,000 terrorist incidents for the period 2007 to 2022.
- Globally, deaths from terrorism fell by 9% to 6,701 deaths, marking a 38% decrease from its peak in 2015.

#### **Passport Index 2023**

According to the latest update from the Passport Index, India's Mobility Scores have decreased, resulting in the country experiencing the largest global drop on the Index this year.

#### **Key Highlights:**

- The Passport Index has released its latest update, which reveals that India's Mobility Score has dropped.
- Other large Asian economies such as Vietnam, Indonesia, China, and Thailand have also experienced declines in their mobility scores, indicating a missed opportunity to capitalize on the global uptick in mobility recorded last year.

- The competition for workers and talent will intensify globally, and many countries will be reliant on migration to realise their long-term growth potential.

#### **World Development Report 2023**

The World Bank published the World Development Report 2023: Migrants, Refugees & Societies.

#### **Key Points:**

- The report estimated a 120% income gain for Indians who migrate to another country for work, compared to a 40% rise in the case of internal migration.

#### **Heat index warning system**

The India Meteorological Department (IMD) is planning to introduce a 'heat index' warning system in Delhi and other parts of the country.

#### **Key Highlights:**

The IMD has conducted a study on the impact of meteorological factors on heatwaves and the "heat wave hazard zonation" of the country.

According to "Hot Weather Analysis over India," IMD revealed that the mechanism by which heat impacts humans is complex, it is a result of the interactions between temperature, radiation, wind, and humidity.






